# DECLARING April 2025 AS AUTISM ACCEPTANCE MONTH & April 2, 2025 AS WORLD AUTISM ACCEPTANCE DAY IN THE CITY OF CALIPATRIA

WHEREAS, Autism is the result of a neurological disorder that affects the functioning of the human brain, and can affect anyone, regardless of race, ethnicity, gender, or socioeconomic background; and

WHEREAS, symptoms and characteristics of Autism may present themselves in a variety of combinations and can result in significant lifelong challenges to an individual's ability to learn in typical ways, develop healthy interactive behaviors, and communicate through verbal, as well as nonverbal methods; and

WHEREAS, the Autism Spectrum Disorder (ASD) is a reality that affects millions of families every day and more children than ever are being diagnosed, resulting in rates as high as one in thirty-six children nationally with four times greater prevalence among boys than girls, equating to approximately one in twenty-five boys, and one in one hundred girls according to the Centers for Disease Control; and

WHEREAS, in April we recognize those with Autism achieving and breaking down barriers, and recommit to helping those on the Autism Spectrum reach their full potential; and

WHEREAS, positive outcomes increase for individuals with Autism when training is provided to professionals across all systems including those in education, healthcare, justice, and emergency response settings; and

CONSENT~ DELTA PUMP STATION EMERGENCY

Subject:

**Delta Pump Station Emergency** 

The Delta Pump Station continues to operate under emergency resolution until repairs are completed.

With the City Council approval of the NADBank Grant Execution on 04.09.2024, NADBank has authorized the City to proceed. Due to the delay in receiving parts, the completion of this project has been delayed.

Arc Performance has already demoed the old piping (suction and discharge) and has installed the new 8" suction valve, the new 10" discharge valve, and the lower and upper shutoff valves.

The new pump has arrived, and once the pipes are set in, we will proceed with the rebuild of the two existing pumps (\$45,000 estimated plus tax). The cost for the pump and rebuilds will be reimbursed by the \$250,000 grant funding.

As a reminder, the City will have a matching of 10% to the cost of the Delta Pump Station Project.

Notice is hereby given that a public hearing will be held by the City of Calipatria City Council at the date. time, and place indicated below. The purpose of the public hearing will be to hear comments from the public regarding the following subject:

Hernandez Park Irrigation System Improvement Project	Hernandez Park located on the west boundary between East Delta Street and East California Street, Calipatria, CA 92233

The City of Calipatria was awarded \$1,164,484 in funding from the State Department of Housing and Community (HCD) under their Development Community Development Block Grant Program-Coronavirus, Aid Relief, Economic Security Act (CDBG-CV1). Per the standard agreement executed by the City and HCD, the funds were allocated for the Hernandez Park Irrigation System Improvement project which consists of the installation of a non-potable water delivery and irrigation system at Hernandez Park, hand washing features at Hernandez Park and Rademacher Park, hands free entry ways and restroom features at the Health and Wellbeing Center and City Hall. Additional improvements consist of the installation of playground equipment with recycled, rubberized surface, shade structures, a monument sign, fencing, and ADA-compliant picnic tables, benches, concrete walkways, and concrete slabs. Construction on the improvements was completed in early 2025 and a close-out report was prepared. The purpose of this public hearing is to notify residents of the project completion and closeout report, in accordance with CDBG-CV1 guidelines, and present the closeout report to the City Council where they will review and motion to approve or not approve the report.



### INTRODUCTION AND BACKGROUND

The City of Calipatria secured funding in the amount of \$1,164,484 from the California Department of Housing and Community (HCD) under their Community Development Block Grant Program (CDBG-CV) pursuant to the Coronavirus Aid, Relief, Economic Security (CARES) Act for the Hernandez Park Irrigation System Improvement project. This grant was intended to provide assistance to public services and local programs; public health, emergency response, or temporary housing facilities that addressed COVID-19 impacts, and grant administration. All CDBG funded activities must benefit low- and moderate income (LMI) persons or meet the CDBG urgent need national objective criteria.

Per the standard agreement executed by the City and HCD, the funds were allocated for the following scope of work: the installation of a non-potable water delivery and irrigation system at Hernandez Park, hand washing features at Hernandez Park and Rademacher Park, and hands-free entry ways and restroom features at the Health and Wellbeing Center and City Hall. Additional improvements consist of the installation of playground equipment with recycled, rubberized surfaces, shade structures, a

monument sign, fencing, and ADA-compliant picnic tables, benches, concrete walkways, and concrete slabs.

According to the project's timeline, the design phase was initiated and prepared by The Holt Group, Inc in early 2023 and was completed by December 22, 2023. Thereafter, the City of Calipatria continued with the bidding process. The first legal advertisement for bidding was published in April and May 2023, but due to a lack of bidders and bid amounts exceeding the grant funds, the City of Calipatria decided to reject the first bid. A second legal advertisement for bidding was published in January 2024 and based on the lowest, responsive, and responsible bid received, Rove Engineering was selected as the project's contractor. Subsequently, the construction phase of the project began in May 2024 and was completed by February 2025. It is important to note that two (2) change orders were arranged during the construction phase of the project to remove and reduce the scope of work due to a funding shortfall.

After the completion of the project in February 2025, the City of Calipatria initiated the closeout process which consists of the following documents to be completed: Closeout Certification, Acquired Property Inventory, Disencumbrance of Funds Acknowledgement, Completion Report Acknowledgement with Completion Report attached, Section 3 Compliance Acknowledgement, Section 3 Closeout Report, Section 3 Qualitative Efforts, and an Affidavit of Posting Notice (See Attachment C). All the aforementioned documents are forms that shall be signed by the City of Calipatria's authorized signatory and the City of Calipatria's City Clerk acknowledging that all special conditions executed by the Standard Agreement were met, all project activities were accomplished, and a public hearing was held to present the project's closeout.

As stated in Table 1 above, the amount awarded for the project's activities (e.g. design, bidding, and construction) was relatively utilized to the greatest extent with only a total amount remaining of \$988.82. Meanwhile, the amount awarded for the project's general administration was also utilized to its greatest extent but had a larger amount of remaining funds totaling \$153,860.93. It is important to note that invoices for the months of January and February are still pending to be submitted for reimbursement. Apart from that, all activity and administration time spent on this project was logged and requested for reimbursement. Every statement and amounts set forth in the Combined Closeout Package and all Financial Reports submitted to HCD are to the best of the City of Calipatria's knowledge, true and correct.

Therefore, the purpose of this public hearing is to present the closeout to the City Council for review and consideration. After opening the floor to public comments, the City Council will vote to approve, conditionally approve, or deny the closeout of the project. If the City Council motions to approve, staff will proceed to complete the closeout process.

### **ENVIRONMENTAL**

The Hernandez Park Irrigation Systems Improvement Project is subject to the National Environmental Policy Act (NEPA) under the Categorical Exclusion Subject to 58.5 (CEST) form as it involves activities that do not cumulatively have a significant impact on the environment but still require compliance with related federal laws and authorities under 24 CFR 58.5. These projects are not automatically exempt from environmental review and must be assessed for potential effects on factors such as historic, preservation, floodplain management, wetlands protection, endangered species, air quality, and environmental justice. The CEST designation ensures that while the project may qualify for a categorical exclusion under NEPA, it still undergoes a thorough review to determine whether additional environmental analysis, including an Environmental Assessment (EA), or Environmental Impact Report (EIR), is necessary before federal funding or approval can proceed. Thus, a CEST 58.5 form was prepared and executed on January 31, 2025 for this project.

### **PUBLIC REVIEW**

Per State grant guidelines and HCD Standard Agreement, the City of Calipatria must conduct a public hearing and post a Notice of Public Hearing in 3-5 public locations concerning discussion of closure and remittal of remaining funds, if any, under HCD-CDBG. Thus, a Notice of Public Hearing was posted at City Hall on March 12, 2025. Subsequently, the Notice of Public Hearing was posted at the City's website, the City's Meyer Memorial Library, and at Rademacher Park on March 13, 2025. Please refer to Attachment A – Public Hearing Notice and Images for additional information.

## **CITY COUNCIL PENDING ACTION**

Per State grant guidelines, the City Council should open the Public Hearing for comments, prior to discussion. The City Council may consider both written and verbal comments received during the Public Hearing or any written communication received prior to the hearing. If no comments or further discussion is necessary, Grant #20-CDBG-CV1-00183 shall be properly closed out.

# CHAPTER 3.15 ART MURALS

#### **Sections:**

- 3.15.050 Prohibited Art Murals
- 3.15.060 Severability

## 3.15.010 Purpose

- A. These regulations relating to Original Art Murals in the City of Calipatria further the following purposes: (1) encouraging artistic expression; (2) fostering a sense of pride; (3) preventing vandalism at mural sites through the installation of murals that vandals are reluctant to disturb; and (4) preserving existing murals that are a valued part of the history of the City of Calipatria.
- B. The City wishes to encourage the installation of murals and, at the same time, prevent the proliferation of off-site commercial signs. Therefore, the City's mural regulations exclude commercial advertising on murals to prevent the installation of the equivalent of an off-site commercial sign on a mural. This restriction on commercial advertising is intended to work in tandem with and help preserve the citywide prohibition of off-site commercial signs, including billboards, as restricted via Section 3.12.030(B)(9) of the City of Calipatria Zoning Ordinance.
- C. These mural regulations also promote public safety and welfare by regulating such displays in keeping with the following objectives:
  - 1. That the design, construction, installation, repair and maintenance of such displays will not interfere with traffic safety or otherwise endanger public safety.
  - 2. That the regulations will provide reasonable protection to the visual environment by controlling the size, height, spacing and location of such displays.
  - 3. That the public will enjoy the aesthetic benefits of being able to view such displays in numbers and sizes that are reasonably and appropriately regulated without having to endure visual blight and traffic safety impacts that would be caused by such displays that are not reasonably and appropriately regulated.
  - 4. That consideration will be given to equalizing the opportunity for messages to be

displayed.

- 5. That adequacy of message opportunity will be available to sign users without dominating the visual appearance of the area.
- 6. That the regulations will conform to judicial decisions, thereby limiting further costly litigation and facilitating enforcement of these regulations.
- 7. To provide registration requirements and regulations for Original Art Murals as defined in Chapter 5.10 of the City of Calipatria Zoning Ordinance.

## 3.15.020 Original Art Mural Registration

- A. **Authority.** The Development Review Committee shall have the authority to determine whether an application for an Original Art Mural or Existing Original Art Mural meets all of the applicable registration requirements as established in this Chapter and provide a recommendation to the City Council Manager.
- B. **Administrative Rules.** The Development Review Committee is authorized and directed to review and enforce the Mural Ordinance Administrative Rules in this Chapter.
- C. Neighborhood Involvement Requirement. All applications for an Original Art Mural or Existing Art Mural shall include a neighborhood involvement requirement. Specifically, an applicant for mural approval shall send notice of that application, in the form of door hangers, to the neighboring properties within a 600-foot radius of where the proposed mural will be installed at least 10 days prior to the Development Review Committee's review. Specifically, an applicant for mural approval shall send notice of that application to the neighboring properties within a 300 foot radius of where the proposed mural will be installed at least 10 days prior to the Project Review Committees decision. If a door tag cannot be placed as a result of a property being vacant or undeveloped, a notice shall be mailed out to the owners of any vacant or undeveloped properties within the 600-meter radius. No mural shall be registered until the applicant certifies that the neighborhood involvement requirement has been completed. This is a procedural requirement only, and the Project Development Review Committee shall review and provide a recommendation to the City Council Manager. The City Council Manager shall at all times retain sole authority to approve or deny an application for a mural based on the criteria in this Chapter.
- D. Fees. The City Council of the City of Calipatria shall adopt applicable fees for mural reviews, such fees shall be fixed by resolution and be in an amount equal to the costs of processing original art mural review applications.

## 3.15.030 Grandfathering of Existing Original Art Murals

Any existing Original Art Mural installed prior to the effective date of this Chapter, shall have legal nonconforming status and, notwithstanding any provision of this Chapter to the contrary, not require registration under this Chapter. But an existing Original Art Mural which has not gained legal nonconforming status through law other than this Chapter cannot qualify for legal nonconforming status under this Chapter if it consists or contains any of the following: electrical or mechanical components, or changing images (moving structural elements, flashing or sequential lights, lighting elements, or other automated methods that result in movement, the appearance of movement, or change of mural image or message, not including static illumination turned off and back on not more than once every 24 hours).

## 3.15.040 Original Art Mural Regulations

An Original Art Mural that meets all of the following content neutral requirements will be allowed upon satisfaction of the applicable registration procedures:

- A. Any alteration to an approved mural shall require a review from the Development review Committee and approval by the Development Review Committee City Manager. "Alterations" include any change to a permitted mural, including, but not limited to, any change to the image(s), materials, colors or size of the permitted mural. "Alteration" does not include naturally occurring changes to the mural caused by exposure to the elements or the passage of time. Minor changes to the permitted mural that result from the maintenance or repair of the mural shall not constitute an "alteration". Such minor changes may include slight and unintended deviations from the original image, colors, or materials that occur when the permitted mural is repaired due to the passage of time or as a result of vandalism.
- B. No part of a mural shall exceed the height of the structure to which it is tiled, painted or affixed.
- C. No part of a mural shall extend more than six (6) inches from the plane of the wall upon which it is tiled, painted or affixed.
- D. No mural may consist of, or contain, electrical or mechanical components, or changing images (moving structural elements, flashing or sequential lights, lighting elements, or other automated methods that result in movement, the appearance of movement, or change of mural image or message, not including static illumination turned off and back on not more than once every 24 hours).
- E. No mural, except for murals consisting completely of paint, shall be placed over the exterior surface of any building opening, including, but not limited to, windows, doors and vents. Notwithstanding the foregoing, a mural consisting of paint or any other material permitted under this Chapter may be placed on roll down security doors on a commercial or industrial building.
- F. No mural shall be placed on a lot that is improved with only one single-family residential structure and accessory structures.
- F. No mural shall be arranged and illuminated in a manner that will produce a light intensity of greater than three-foot candles above ambient lighting, as measured at the property line of the nearest residentially zoned property.
- G. Digitally printed image murals shall be reviewed by the Development Review Committee and provide a recommendation to the City Council Manager. Receive approval of the City of Calipatria City Manager and Fire Department.
- H. Damaged Original Art Murals shall be repaired within ten (10) days of being damaged or vandalized. Such repairs may include slight and unintended deviations from the original image, colors, or materials. The City Manager may extend the time or waive this requirement upon review of the damaged mural.
- I. Original Art Murals vandalized with vulgar or inappropriate language by graffiti shall be covered or repaired within twenty-four seventy-two (2472) hours of being damaged or vandalized. Such repairs may include slight and unintended deviations from the original image, colors, or materials. The City Manager may extend the time or waive this

# requirement upon review of the vandalized mural.

### 3.15.050 Prohibited Art Murals

Murals may not include Constitutionally unprotected speech which includes any message or image that is outside the protection of the First Amendment of the U.S. Constitution and/or corollary provisions of the California Constitution, such as obscenity, and hate speech or imagery are prohibited.

## 3.15.060 Severability

If any part, sentence, phrase, clause, term, or word of this Chapter is declared invalid or unconstitutional by a valid court judgment or decree of any court of competent jurisdiction, the declaration of such invalidity or unconstitutionality shall not affect the constitutionality or lawfulness of the remainder of this Administrative Code, the City of Calipatria Zoning Ordinance, or any other City regulation regulating signage, billboards, or Original Art Murals.
