 Adopt resolution 24-28 adopting the Church Street improvement project for fiscal year 2024-25 funded by SB -1 THE ROAD REPAIR AND ACCOUNTABILITY ACT OF 2017

WHEREAS, Senate Bill 1 (SB 1), the Road Repair and Accountability Act of 2017 (Chapter 5, Statutes of 2017) was passed by the Legislature and signed into law by the Governor in April 2017 to address the significant multi-modal transportation funding shortfalls statewide; and

WHEREAS, SB 1 includes accountability and transparency provisions that will ensure the residents of our City are aware of the projects proposed for funding in our community and which projects have been completed each fiscal year; and

WHEREAS, the City must adopt by resolution a list of projects proposed to receive fiscal year funding from the Road Maintenance and Rehabilitation Account (RMRA), created by SB 1, which must include a description and the location of each proposed project, a proposed schedule for the project's completion, and the estimated useful life of the improvement; and

WHEREAS, the City, will receive an estimated \$171,222.00 in RMRA funding in Fiscal Year 2024-25 from SB 1; and

WHEREAS, this is the 6th year in which the City is receiving SB 1 funding and will enable the City to continue essential road maintenance and rehabilitation projects, safety improvements, repairing and replacing aging bridges, and increasing access and mobility options for the traveling public that would not have otherwise been possible without SB 1; and

WHEREAS, the City has undergone a robust public process to ensure public input into our community's transportation priorities/the project list; and

WHEREAS, the City used a pavement conditions survey completed in 2017 to develop the SB 1 project list to ensure revenues are being used on the most high-priority and cost-effective projects that also meet the communities priorities for transportation investment; and

WHEREAS, the funding from SB 1 will help the City maintain and rehabilitate certain streets/roads and active transportation infrastructure throughout the City this year and of similar projects into the future; and

WHEREAS, the 2018 California Statewide Local Streets and Roads Needs Assessment found that the City streets and roads are in a "poor" condition and this revenue will help us increase the overall quality of our road system and over the next decade will bring our streets and roads into an "excellent" condition; and

WHEREAS, the SB 1 project list and overall investment in our local streets and roads infrastructure with a focus on basic maintenance and safety, investing in complete streets infrastructure, and using cutting-edge technology, materials and practices, will have significant positive co-benefits statewide.

NOW, THEREFORE IT IS HEREBY RESOLVED, ORDERED AND FOUND by the City Council of the City of Calipatria, State of California, as follows:

- 1. The foregoing recitals are true and correct.
- 2. The following list of newly proposed projects will be funded in-part or solely with Fiscal Year 2024-25 Road Maintenance and Rehabilitation Account revenues:

Project Title: North Industrial Avenue Street Improvement Project

Project Description: The project involves the removal and disposal of existing deteriorated asphalt pavement and installing new 3-inch asphalt rubber hot mix overlay over new class 2 base subgrade. The project also includes the installation of new class 2 base shoulders and adjusting existing utility frame covers to finish pavement grade. Striping and signage is also included in the scope of work.

Project Location: North Industrial Avenue between Highway 115 and Young Road

Estimated Project Schedule: July 2024 to June 2025

Estimated Project Useful Life: 20 years

WHEREAS, pursuant to Elections Code Section 10002, the governing body of any city or district may be resolution request the Board of Supervisors of the county to permit the county elections official to render specified services to the city or district relating to the conduct of an election; and

WHEREAS, the resolution of the governing body of the city shall specify the services requested; and

WHEREAS, pursuant to Elections Code Section 10002, the city shall reimburse the county in full for the services performed upon presentation of a bill to the city; and

WHEREAS, pursuant to Elections Code 10400, whenever two or more elections, including bond elections, of any legislative or congressional district public district, city, county, or other political subdivision are called to be held on the same day, in the same territory, or in territory that is in part the same, they may be consolidated upon the order of the governing body/bodies or officer/officers calling the elections; and

WHEREAS, pursuant to Elections Code 10400, such election for cities and special districts may be either completely or partially consolidated; and

WHEREAS, pursuant to Elections Code Section 10403, whenever an election called by a district, city or other political subdivision for the submission of any question, proposition, or office to be filled is to be consolidated with a statewide election, and the question, proposition, or office to be filled is to appear upon the same ballot as that provided for that statewide election, the district, city or other political subdivision shall, at least 88 days prior to the date of the election, file with the board of supervisors, and a copy with the elections official, a resolution of its governing board requesting the consolidation, and setting forth the exact form of any question, proposition, or office to be voted upon at the election, as it is to appear on the ballot, acknowledging that the consolidation election will be held and conducted in the manner prescribed in Section 10418. Upon such request, the Board of Supervisors may order the consolidation; and

WHEREAS, pursuant to Elections Code Section 10418, if consolidated, the consolidated election shall be held and conducted, election boards appointed, voting precincts designated, candidates nominated, ballots printed, polls opened and closed, voter challenges determined, ballots counted and returned, returns canvassed, results declared, certificates of election issued, recounts conducted, election contests presented, and all other proceedings incidental to and connected with the election shall be regulated and done in accordance with the provisions of law regulating the statewide or special election, or the election held pursuant to Section 1302 or 1303, as applicable.

WHEREAS, the resolution requesting the consolidation shall be adopted and filed at the same time as the adoption of the ordinance, resolution, or order calling the election; and WHEREAS, various district, county, state and other political subdivision elections may be or have been called to be held on November 5, 2024. NOW THEREFORE BE IT RESOLVED AND ORDERED that the governing body of the City of Calipatria hereby orders and election be called and consolidated with any and all elections also called to be held on November 5, 2024 insofar as said elections are to be held in the same territory that is in part the same as the territory of City of Calipatria requests the Board of Supervisors of the County of Imperial to order such consolidation under Elections Code Section 10401 10403 and 10418.

On April 23, 2024, the City approved California Consulting, Inc. as a consultant for professional services for assistance with grant writing. City staff is currently working on submission of several grants for Police, Fire, and Public Works.

GRANT WRITING SERVICES AGREEMENT

DATED:

May 28, 2024

PARTIES:

California Consulting, Inc. (hereinafter the "Consultant"); and

City of Calipatria, (hereinafter the "Client")

AGREEMENT:

The undersigned hereby agree to the following terms and conditions:

Section 1. <u>Duties of Consultant</u>: During the term of this Agreement, Consultant shall provide the Client as follows:

- a. Grant research, targeted grant research on projects specifically identified by the client, identification of funding opportunities, staff training, and grant writing services at direction of Client;
- b. Offering Client general advice on matters involving funding mechanisms, grants research, identification, and writing; and
- c. Perform post-grant award administration on the grants which are awarded to the Client, including the filing of required documents by the proscribed deadlines set by the awarding entity.
- Section 2. <u>Time for Performance of Duties</u>: Notwithstanding any other term or condition of this Agreement, Client specifically acknowledges that Consultant has other clients and/or outside employment. Consultant shall have control over the time and manner of performing its duties described in Section 1, and shall make available such time as it, in its sole discretion, shall deem appropriate for the performance of its duties under this Agreement. Although Client understands that Consultant has other clients and responsibilities, Consultant acknowledges that if and when a grant has been awarded, Consultant will make sure that any deadlines or filings will be a priority during the term of the grant.
- **Section 3.** Term of the Agreement: The effective date of this Agreement is May 22, 2024, and shall continue on a month to month basis allowing either party to discuss new terms at any time.
- **Section 4.** Compensation: Client shall pay Consultant on an hourly basis as compensation for Consultant's grant writing services as described in Section 1. Consultant will provide Client with a written invoice. Client agrees to pay invoice within 30 (thirty) days of receipt.

Section 5. Expenses: The Client agrees to reimburse the Consultant for reasonable out-of-pocket expenses related to performing services on behalf of the Client. Such expenses typically might include, but are not limited to, mileage, conference calls, copies, binding

costs, postage, parking, travel, and lodging expenses. Consultant shall provide Client with a receipt and a description of the expense with the invoice.

- **Section 6.** Relationship: Consultant shall perform its grant writing services hereunder as an independent contractor and not as an employee of the Client or an affiliate thereof. It is expressly understood and agreed to by the parties hereto that Consultant shall have no authority to act for, represent or bind the Client or any affiliate thereof in any manner, except as may be agreed to expressly by the Client in writing from time to time.
- Section 7. <u>Confidentiality</u>: Except in the course of the performance of its duties hereunder, each party agrees that it shall not disclose any trade secrets, know-how, or other proprietary information not in the public domain learned as a result of this Agreement. Similarly, the parties agree that they shall not disclose or divulge this Agreement, or any of its term or conditions to third parties, except as is necessary to perform the terms and conditions stated herein.
- Section 8. <u>Indemnification</u>: The Client agrees to indemnify and hold harmless the Consultant, its members, officers, directors, employees, attorneys, and contractors and each person who controls Consultant or any of its affiliates from and against any demands, losses, claims, actions or causes of action, damages, judgment, arbitration awards, liabilities (whether absolute or accrued, contingent or otherwise), costs, and expenses whatsoever (including reasonable costs of investigation or defending any action) to which they or any of them may become subject under any applicable law arising out of Consultant's performance under this Agreement and will reimburse Consultant for all expenses (including counsel fees) as they are incurred. Consultant maintains liability insurance in the amount of one million dollars.
- **Section 9.** <u>Assignment</u>: This Agreement shall not be assignable by either party; provided however, that Consultant shall have the discretion to allocate its duties hereunder to owners, affiliates, or employees of Consultant.
- Section 10. <u>No Guaranteed Result:</u> Client acknowledges and agrees that Consultant does not have control over third party decision makers, and therefore Consultant makes no representations, warranties or guarantees that it can achieve any particular results. Consultant, however, shall act in good faith toward the performance of its duties described above.
- **Section 11. Prior Agreements:** This Agreement shall supersede any prior agreements between the parties, and serves as the sole and only agreement between them. This Agreement may only be modified by a writing signed by both parties.
- **Section 12.** Governing Law: This Agreement shall be deemed to be a contract made under the laws of the State of California and for all purposes shall be construed in accordance with the laws of said State.
- **Section 13.** Attorney's Fees: The prevailing party in any action filed that arises out of this Agreement shall be entitled to recoup their reasonable attorney's fees and costs from the other party.

Client shall compensate Consultant for all services rendered prior to the date of termination. There shall be no liquidated damages in the event of termination under this provision.

INTERIM POLICE CHIEF

EMPLOYMENT AGREEMENT

THIS EMPLOYMENT AGREEMENT (the "Agreement") is entered into this 14th day of May 2024, by and between the CITY OF CALIPATRIA, a California municipal corporation (hereinafter the "City") and CHERYL FOWLER (hereinafter "Employee") and is effective May 14, 2024, until the City hires a new Police Chief and that Chief starts work.

WHEREAS the former Police Chief Lynn M. Mara retired on March 31, 2024; and

WHEREAS the City desires to employ Cheryl Fowler as an interim Police Chief; and

WHEREAS it is the desire of the City Council to provide certain conditions of employment and set working conditions and conditions of temporary employment; and

NOW, THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES CONTAINED HEREIN, THE PARTIES AGREE AS FOLLOWS:

EMPLOYMENT

I. The City hereby agrees that Cheryl Fowler is employed as the interim Police Chief for the City of Calipatria, effective May 14, 2024, and Cheryl Fowler hereby accepts under such employment, the terms and provision of this Agreement.

DUTIES

- II. **Scope of Work**. The Employee shall perform all those responsibilities, duties, and obligations as set forth in the City of Calipatria Police Chief Position job description and such other duties and responsibilities as are legally and properly assigned by the City Manager and/or City Council from time to time.
- III. **Exempt Position**. The Employee is designated as an FLSA Executive Exempt employee and subject to the City Administrator's approval, is permitted to design a flexible work schedule as may be warranted to accomplish the continuing objectives of the City.
- IV. **Exclusive Employment.** During the term of this Agreement, Employee agrees to remain exclusively employed by the City and not

to become employed by any other employer until the effective date of termination or resignation. The term "employed" shall not be interpreted to include occasional teaching, writing, or consulting work which does not interfere or conflict with the Employee's ability to effectively discharge her assigned duties.

V. **Hours of Work.** The standard workweek is forty (40) hours, but Employee's schedule of work shall vary in accordance with the work required to be performed, including such time as is necessary outside normal office hours.

SALARY

VI. Commencing on May 14, 2024, Employee's base salary shall be **Seven Thousand Two Hundred Fifty Dollars (\$7,250.00)** per month.

PERFORMANCE EVALUATION

VII. The City Manager will ordinarily review and evaluate the performance of Employee as needed. Performance and evaluations shall be in accordance with City of Calipatria Personnel Policies and Procedures. The City Manager and Employee shall define goals and performances objectives of the City's Police Department and shall further establish a relative priority among those various goals and objectives within the annual operating and capital budgets and the appropriations provided.

BENEFITS

- VIII. Employee shall be covered by same benefits (sick leave, vacation, administrative, etc.) as provided to non-exempt employees.
- IX. Employee shall be covered under the City's associated cities risk pool insurance for any tort, professional liability claims or demand, or any other legal action, whether groundless or not, subject to the terms and limitations of that insurance coverage.
- X. The City shall provide a police vehicle to enable Employee to respond from home or otherwise away from the office; provided, however, that the vehicle may be used for personal business subject to City policy on take home vehicles.

TERMINATION AND RESIGNATION

XI. **Termination.** The City can terminate Employee at any time for any cause, with or without notice subject to applicable Federal and State

laws. Employee shall be entitled to compensation up through the last day of actual service.

XII. **Employee Initiated Resignation**. Nothing herein shall prevent or limit Employee's right to resign at any time from her employment with the City, provided, however, that Employee is required to provide thirty (30) days' notice prior to the effective date of resignation.

TERM

- XIII. This Agreement shall commence on May 14, 2024, and shall terminate upon the employment commencement date of a permanent Police Chief employed by the City.
- XIV. Nothing in this agreement shall prevent, limit, or otherwise interfere with the right of the City to terminate the services of the Interim Police Chief at any time, subject to the provisions set forth in this agreement.

GENERAL PROVISIONS

XV. **Notice.** All required notices by the City to the Employee or by Employee to the City shall be delivered either personally to the addressee or may be deposited in the United States Mail, postage prepaid, to the address of the person receiving the notice, indicated below. Any notice so posted in the United State Mail shall be deemed received three (3) days after the date of mailing and the effective date of any such notice shall be the date of mailing.

A party may update their notice address by providing written notice to the other party.

XVI. **Dispute Resolution.** Any disputes shall first be submitted to mediation. If mediation is unsuccessful, or if either party refuses to engage in mediation, the dispute shall be decided by binding arbitration before the Judicial Arbitration and Mediation Services ("JAMS") located in San Diego, CA. Each party shall bear the costs of preparation and presentation, including attorneys' fees and expert witness fess, of its case before arbitration. The cost of the arbitrator

shall be shared equally. The decision of the arbitrator shall be binding and final on the parties. The arbitration shall be conducted in accordance with the JAMS Comprehensive Arbitration Rules and Procedures unless the parties agree otherwise. The Agreement shall be governed by the laws of the State of California.

- XVII. **Non-Waiver.** Failure by any of the parties to insist upon the strict performance of any covenant, duty, term, agreement, or condition of this Agreement or to exercise any right or remedy consequent upon a breach thereof, shall constitute a waiver of any such breach or covenant, duty, term, agreement, or condition. Any party hereto, by notice, and only by notice as provided herein may, but shall be under no obligation to, waive any of their rights or any conditions to their obligations hereunder, or any duty, obligation, or covenant. No waiver of any provision of the Agreement shall be deemed a waiver of any other provision of this Agreement, and each covenant, agreement, term, and condition of this Agreement shall continue to be in full force and effect with respect to any other existing or subsequent breach thereof.
- XVIII. **Severability.** If any term or provision contained in this Agreement is held to be invalid, illegal, or unenforceable in any respect, such invalidity, illegality, or unenforceability shall not affect any other term or provision of this Agreement, and this Agreement shall be construed as if such invalid, illegal, or unenforceable provision had never been contained herein.
- XIX. **Neutral Authorship.** Each of the provisions of this Agreement has been reviewed and negotiated and represents the combined work product of all parties hereto. No présumption or other rules of construction which would interpret the provisions of this Agreement in favor of or against the party preparing the same shall be applicable in connection with the construction or interpretation of any of the provision of this Agreement.

FIRE ENGINE EMERGENCY UPDATE

At the March 26, 2024, city council meeting, I presented to council the emergency request to approve the Calipatria Fire Department's purchase of the 1995 Central State fire engine from Brawley Fire to replace Calipatria fire engine 5212, a 2001 American La France fire engine that is no longer operational. Council voted to approve the purchase of the fire engine from Brawley Fire using the strike team reimbursement checks from the "Rabbit" incident with a total of \$20,271.66, received on April 15, 2024, and an additional strike team reimbursement check from the "Silverado" incident totaling in \$4,692.60, received on May 17, 2024, giving a total \$24,964.26 to be used. Both checks have been processed and deposited into the city's bank account.

With the authorization from Council's approval from the March 26, 2024, meeting, I will be moving forward with the purchase of the fire engine from Brawley Fire. Utilizing the funds from the strike team reimbursements totaling \$24,964.26 with the remaining balance of \$14,964.26 after the \$10,000.00 for the purchase of the fire engine, will be used to outfit and equipping the fire engine. The surplus sale of 5212 funds received will also be used toward any other equipment or maintenance that may be needed to further help with putting the fire engine into service for the City of Calipatria Fire Dept.

INTRODUCTION AND BACKGROUND

The Mills-Alquist-Deddeh Act (SB 325) was enacted by the California Legislature to improve existing public transportation services and encourage regional transportation coordination. Known as the Transportation Development Act (TDA) of 1971, this law provides funding to be allocated to transit and non-transit related purposes that comply with regional transportation plans. TDA established two funding sources; the Local Transportation Fund (LTF), and the State Transit Assistance (STA) fund. Providing certain conditions are met, counties with a population under 500,000 (according to the 1970 federal census) may also use the LTF for local streets and roads, construction and maintenance. The STA funding can only be used for transportation planning and mass transportation purposes. On April 28, 2017 Governor Brown signed Senate Bill (SB) 1 (Chapter 5, Statutes of 2017), known as the Road Repair and Accountability Act of 2017. Senate Bill 1 (SB 1) augments the base of the State Transit Assistance program essentially doubling the funding for this program. To provide for SB 1 reporting and transparency, transit agencies are asked to work with the Department to report on planned expenditures for these augmented funds.

AVAILABLE FUNDING AND PROJECT SELECTION

There are three programs for which the City must submit claim forms and adopt resolutions identifying project or activities for which funds will be utilized. Annual allocations are based on population.

Article 8e funds are available for is given for transit services as well as for projects meeting public transportation needs. Eligible projects include, but are not limited to, the maintenance, improvements, and/or installation of bus shelters and/or benches. The City has been allocated \$1,524.00 for FY 24/25. The City must select projects for fund allocation and thus the following project is being proposed to be completed under the Article 8 (e) Allocation for FY 19/20: The City intends to purchase and install bus shelters. These funds may be used for the new bus stop proposed in the east side of the railroad tracks. Funds from previous fiscal years will be used to augment funds for FY 24/25.

Article 3 of the Local Transportation Fund (LTF) provides funding for the administration of the Transportation Development Act (TDA) in Imperial County and certain other TDA high priority programs. Under this Article, the first priority for LTF Funding is given to TDA program administration and planning. Funding is also designated for pedestrian and bicycle programs, and rail passenger service (if such services were offered in Imperial County). Eligible pedestrian and bicycle projects include, but are not limited to, curbs, handicap access ramp projects, sidewalks, pedestrian ways, bikeways, bike racks and bicycle storage, and bicycle safety education programs. The City has been allocated \$12,459.00 for FY 24/25.

Road Maintenance and Rehabilitation Account (RMRA) was established to provide funding to address deferred maintenance of the local street and road system. The amount available to the City is \$171,222.00. The project selected is the North Industrial Avenue Street Improvement Project which involves the removal and disposal of existing deteriorated asphalt pavement and installing new 3-inch asphalt rubber hot mix overlay over new class 2 base subgrade. The project also includes the installation of new class 2 base shoulders and adjusting existing utility frame covers to finish pavement grade. Striping and signage is also included in the scope of work.

FISCAL IMPACT/PENDING ACTION

No local match is required and other than staff time required for completing claim forms, ordering equipment, and project management, no fiscal impact to the General Fund is anticipated.

ACTION REQUIRED

- 1. Adopt Resolution <u>24–26</u> approving the allocation of funds for the FY 24/25 purchase and installation of bus shelter benches and/or equipment in the amount of \$1,573.
- 2. Adopt Resolution <u>24-27</u> approving the allocation of funds for purchase and installation of pedestrian safety signage on local streets near schools.
- 3. Adopt Resolution <u>24-28</u> approving North Industrial Avenue Street Improvement Project for funding under the FY 24/25 Road Maintenance and Rehabilitation Account
