All sealed bids must be submitted at City Hall, City of Calipatria, located at 125 North Park Avenue, Calipatria, California 92233, no later than 2:00 p.m. on Thursday, November 6, 2025.

2. <COMBINED TOTAL BID SUMMARY FORM>

The Combined Total Bid Summary Form for Project I and Project II is hereby issued with this addendum, identified as **Addendum No. 1 – Attachment A**.

The Combined Total Bid Summary Form for Project I and Project II will be used to determine the lowest bidder. The Bidders are required to submit complete and separate proposals for each project. Each project is separate for funding and tracking purposes and will be administered separately throughout the construction phase of the project. Failure to submit bids for both projects will result in the bid being considered incomplete, non-responsive, and disqualified.

Three (3) separate sealed envelopes must be submitted, labeled as follows:

1. Sealed Proposal for PROJECT I – South Brown Avenue Roadway Improvements
2. Sealed Proposal for PROJECT II – Main Street Roadway Improvements
3. Sealed Proposal for Combined Total Bid Summary Form

Each envelope must clearly display the bidder's name, address, and a description of its contents as specified above.

3. <AWARD OF CONTRACT PROVISIONS>

- A. The entire paragraph under "1.7 - Acceptance or Rejection of Bids" of Section II – Instructions to Bidders of the Project Specifications is hereby replaced with the following:

The contract will be awarded to the lowest, responsive, responsible bidder of the Combined Total Bid of the two (2) bundled projects, Project I and Project II, as described within the Invitation for Proposals section of the Project Specifications. The City reserves the right to accept or reject any and all bids and to waive any informality or irregularity in any bid received.

- B. Only the sealed envelope containing the Combined Total Bid Summary Form will be opened at Bid Opening.

4. <DISADVANTAGED BUSINESS ENTERPRISE (DBE) PROGRAM>

On September 30, 2025, the U.S. Department of Transportation issued an Interim Final Rule that makes major changes to the DBE Program. The rule was published in the *Federal Register* on October 3, 2025, and became effective immediately.

Bidders are hereby advised that, in accordance with the DBE Interim Final Rule published in 49 CFR Part 26 on October 3, 2025, **the DBE goal for this project has been eliminated**. As a result, all submission, monitoring, and implementation requirements related to DBE goal participation and good faith efforts—as outlined in the Project Specifications and Contract Documents—are no longer applicable to this project.

For further information regarding this change, please refer to the letter issued by the Caltrans Office of Civil Rights, dated October 7, 2025, included as "**Addendum No. 1 – Attachment B.**"

5. <FEDERAL WAGE 10 DAYS UPDATE> The most current United States Department of Labor Federal Davis-Bacon (federal) wage rates (10 Days Update) were checked on October 27, 2025. The latest wage rates have been updated to CA 20250002 Modification 16 10/03/2025.

Remove and replace the federal wage rates included in Section IV of the Project Specifications with the updated federal wage rates dated October 3, 2025, as attached to this addendum, as “**Addendum No. 1 – Attachment C**”.

6. <CLARIFICATION - PAVING OPERATIONS IN CALTRANS RIGHT-OF-WAY>

The City of Calipatria has obtained an Encroachment Permit from Caltrans for construction activities encroaching on Highway 115. A copy of the approved permit is included in the Special Conditions section of the Specifications.

To comply with the conditions of the Encroachment Permit, the Contractor shall coordinate and participate in a pre-paving conference with the designated Caltrans representative(s) prior to commencing any paving operations within the Caltrans Right-of-Way. Prior to the start of work, the following submittals must be reviewed and approved by Caltrans: the Job Mix Formula (JMF) for hot mix asphalt, concrete mix designs, the Quality Control (QC) Plan, traffic control devices, and other related items.

All costs associated with compliance with the Encroachment Permit requirements and any directives issued by Caltrans representatives shall be considered incidental to the related bid items. No additional or separate compensation will be provided.

To: All Disadvantaged Business Enterprise Program Stakeholders:

On September 30, 2025, the U.S. Department of Transportation (DOT) issued an [Interim Final Rule \(IFR\)](#) making significant changes to the Disadvantaged Business Enterprise (DBE) and Airport Concession DBE (ACDBE) Programs. The IFR was published in the Federal Register on October 3, 2025, and is effective immediately. Caltrans and all subrecipients of federal transportation funding subject to the DBE Program are required to comply.

While we continue to evaluate the new IFR, we want to share the information below to keep you apprised of this development and new requirements. We will share additional information when available.

However, as an interim action and to ensure compliance with federal direction, here are DBE program changes effective immediately:

Key Changes

- **Elimination of Presumptions:** Race-and gender-based presumptions of social and economic disadvantage are removed. All applicants must now demonstrate social and economic disadvantage through individualized evidence, including a personal narrative and financial documentation.
- **Reevaluation of All Firms:** Every currently certified DBE/ACDBE will undergo reevaluation. Firms meeting the new standards will be recertified; those that do not will be decertified.
- **Temporary Suspension of Goals and Counting:** Until reevaluations are complete, Caltrans and all subrecipients must **not**:
 - Set DBE/ACDBE contract goals.
 - Count DBE/ACDBE participation toward overall program goals.
- **Existing Contracts:** Contracts already awarded remain valid; however, DBE/ACDBE commitments and participation under those contracts cannot be

counted toward goal attainment during the reevaluation period. Primes may self-perform or subcontract work as necessary, without DBE credit, if a DBE is terminated. Those DBEs that are actual subcontractors (not just material suppliers), primes still need to follow subcontracting rules (i.e., termination, substitution, etc.) even if the DBE subcontractors are no longer “DBEs.”

- **Goal Setting:** All DBE goal requirements are suspended effective October 3, 2025. Do not set DBE goals on contracts. Contracts currently advertised or pending award with DBE goals must have their DBE goals removed. Statewide DBE goal setting will resume once reevaluations of all DBEs are complete.
- **Reporting Requirements:** DOT has eliminated the collection of race-and sex-specific ownership data; reporting will instead focus on certification status and individualized eligibility. We await DOT guidance on the collection of data for future reporting.

Next Steps

- **Caltrans Staff:** Will apply the new certification standards immediately and will work with the Unified Certification (UCP) Partners to reevaluate all certified firms.
- **CUCP Partners:** Update the UCP Standard Operating Procedures, approve the new Personal Narrative requirement, begin applying the new certification standards immediately, and reevaluate all certified firms.
- **Prime Contractors:** Do not submit utilization plans or commitments tied to DBE credit during this transition. Ensure solicitations to your subcontractors on advertised projects pending award are amended to reflect zero DBE goals until further notice.
- **Certified DBEs:** Be prepared to submit individualized documentation of disadvantage as part of the reevaluation process. Templates and technical assistance will be provided by your certifying agency, including Caltrans.
- **Local Agencies:** Pause inclusion of DBE goals in all federally assisted solicitations. Work with your Legal to implement addenda where solicitations are already advertised. Caltrans Civil Rights staff are available to provide technical assistance or suggest language.

Again, Caltrans will issue further detailed instructions, host training sessions, and provide outreach to ensure all partners understand and comply with the new requirements.

We recognize the burden these immediate changes create for firms, contractors, and local agencies. Our Office of Civil Rights is committed to supporting you through this transition.

GROUP 4: Asphalt raker, lute person, ironer, asphalt dump person, and asphalt spreader boxes (all types); Concrete core cutter (walls, floors or ceilings), grinder or sander; Concrete saw person, cutting walls or flat work, scoring old or new concrete; Cribber, shorer, lagging, sheeting and trench bracing, hand-guided lagging hammer; Head rock slinger; Laborer, asphalt- rubber distributor boot person; Laser beam in connection with laborers' work; Oversize concrete vibrator operator, 70 lbs. and over; Pipelayer performing all services in the laying and installation of pipe from the point of receiving pipe in the ditch until completion of operation, including any and all forms of tubular material, whether pipe, metallic or non-metallic, conduit and any other stationary type of tubular device used for the conveying of any substance or element, whether water, sewage, solid gas, air, or other product whatsoever and without regard to the nature of material from which the tubular material is fabricated; No-joint pipe and stripping of same; Prefabricated manhole installer; Sandblaster (nozzle person), water blasting, Porta Shot-Blast

GROUP 7: A Frame, Swedish crane or similar; Forklift driver; Ross carrier driver

GROUP 9: Truck repair person/welder; Low bed driver, 9 axles or over

Note: Executive Order (EO) 13706, Establishing Paid Sick Leave for Federal Contractors applies to all contracts subject to the Davis-Bacon Act for which the contract is awarded (and any solicitation was issued) on or after January 1, 2017. If this contract is covered by the EO, the contractor must provide employees with 1 hour of paid sick leave for every 30 hours they work, up to 56 hours of paid sick leave each year. Unlisted classifications needed for work not included within the scope of the classifications listed may be added after award only as provided in the labor standards contract clauses (29CFR 5.5 (a) (1) (iii)).

The body of each wage determination lists the classifications and wage rates that have been found to be prevailing for the type(s) of construction and geographic area covered by the wage determination. The classifications are listed in alphabetical

order under rate identifiers indicating whether the particular rate is a union rate (current union negotiated rate), a survey rate, a weighted union average rate, a state adopted rate, or a supplemental classification rate.

Union Rate Identifiers

A four-letter identifier beginning with characters other than ""SU"", ""UAVG"", ?SA?, or ?SC? denotes that a union rate was prevailing for that classification in the survey. Example: PLUM0198-005 07/01/2024. PLUM is an identifier of the union whose collectively bargained rate prevailed in the survey for this classification, which in this example would be Plumbers. 0198 indicates the local union number or district council number where applicable, i.e., Plumbers Local 0198. The next number, 005 in the example, is an internal number used in processing the wage determination. The date, 07/01/2024 in the example, is the effective date of the most current negotiated rate.

Union prevailing wage rates are updated to reflect all changes over time that are reported to WHD in the rates in the collective bargaining agreement (CBA) governing the classification.

Union Average Rate Identifiers

The UAVG identifier indicates that no single rate prevailed for those classifications, but that 100% of the data reported for the classifications reflected union rates. EXAMPLE: UAVG-OH-0010 01/01/2024. UAVG indicates that the rate is a weighted union average rate. OH indicates the State of Ohio. The next number, 0010 in the example, is an internal number used in producing the wage determination. The date, 01/01/2024 in the example, indicates the date the wage determination was updated to reflect the most current union average rate.

A UAVG rate will be updated once a year, usually in January, to reflect a weighted average of the current rates in the collective bargaining agreements on which the rate is based.

Survey Rate Identifiers

The ""SU"" identifier indicates that either a single non-union rate prevailed (as defined in 29 CFR 1.2) for this classification in the survey or that the rate was derived by computing a weighted average rate based on all the rates reported in the survey for that classification. As a weighted average rate includes all rates reported in the survey, it may include both union and non-union rates. Example: SUFL2022-007 6/27/2024. SU indicates the rate is a single non-union prevailing rate or a weighted average of survey data for that classification. FL indicates the State of Florida. 2022 is the year of the survey on which these classifications and rates are based. The next number, 007 in the example, is an internal number used in producing the wage determination. The date, 6/27/2024 in the example, indicates the survey completion date for the classifications and rates under that identifier.

?SU? wage rates typically remain in effect until a new survey is conducted. However, the Wage and Hour Division (WHD) has the discretion to update such rates under 29 CFR 1.6(c)(1).

State Adopted Rate Identifiers

The ""SA"" identifier indicates that the classifications and prevailing wage rates set by a state (or local) government were adopted under 29 C.F.R 1.3(g)-(h). Example: SAME2023-007 01/03/2024. SA reflects that the rates are state adopted. ME refers to the State of Maine. 2023 is the year during which the state completed the survey on which the listed classifications and rates are based. The next number, 007 in the example, is an internal number used in producing the wage determination. The date, 01/03/2024 in the example, reflects the date on which the classifications and rates under the ?SA? identifier took effect under state law in the state from which the rates were adopted.

WAGE DETERMINATION APPEALS PROCESS

1) Has there been an initial decision in the matter? This can be:

- a) a survey underlying a wage determination
- b) an existing published wage determination
- c) an initial WHD letter setting forth a position on a wage determination matter
- d) an initial conformance (additional classification and rate) determination
