CONSENT~ DELTA PUMP STATION EMERGENCY

Subject:

Delta Pump Station Emergency

The Delta Pump Station continues to operate under emergency resolution until repairs are completed.

With the City Council approval of the NADBank Grant Execution on 04.09.2024, NADBank has authorized the City to proceed. Due to the delay in receiving parts, the completion of this project has been delayed.

Arc Performance has already demoed/installed all piping (suction and discharge) and has installed the new 8" suction valve, the new 10" discharge valve, pump, meter, and the lower and upper shutoff valves. ARC Performance has completed their contract.

The City will proceed with the rebuilding of the two existing pumps (\$45,000 estimated plus tax). The cost for the pump and one rebuild will be reimbursed by the \$250,000 grant funding. The pump that was being evaluated was deemed unrepairable, and the last one was dropped off two weeks ago for evaluation.

As a reminder, the City will have a matching of 10% to the cost of the Delta Pump Station Project.

INTRODUCTION AND BACKGROUND

On March 31, 2025, the Southern California Association of Governments (SCAG) initiated a call for project nominations for the Congestion Mitigation and Air Quality (CMAQ) Improvement Program for federal fiscal years 2026-2027 and 2027-2028. The CMAQ Program is a federal transportation funding source for projects and programs that reduce traffic and improve air quality for areas that do not meet the National Ambient Air Quality Standards for

ozone, carbon monoxide or particulate matter (nonattainment areas) and for former nonattainment areas that are now in compliance (maintenance areas). In response to the call for project nominations, the City of Calipatria applied for CMAQ funding for the Railroad Avenue Pedestrian Improvements Project between Main Street/SR 115 and Date Street. To proceed with the application, applicants are required to submit a resolution, from their governing bodies, authorizing the application submittal. Draft resolutions are permitted on the condition that an executed resolution be provided soon upon submittal.

The purpose of this item is to present the CMAQ application for the Railroad Avenue Pedestrian Improvements Project to the City Council where they will review all pertinent information and motion to either adopt or not adopt a resolution authorizing the submittal of a CMAQ application for federal funding.

ISSUES FOR DISCUSSION

Railroad Avenue connects south to Date Street and is primarily used by residents to access the adjacent single-family homes. The project location currently lacks pedestrian facilities along the eastern boundary between Main Street/SR 115 and Date Street. The project proposed the installation of an approximately 1,580 foot long and 6-foot-wide P.C.C. Curb & Gutter and Sidewalk on the east side of Railroad Avenue from Main Street/SR 115. As a minor collector, with an estimated Annual Average Daily Traffic (AADT) of 4000 vehicles according to the 2022 Caltrans Traffic Census Data, Railroad Avenue serves as an alternate road to the south and east of the city. The installation of a new sidewalk is necessary not only for safety but to accommodate the current and future needs of nonmotorized travelers (including but not limited to pedestrians, bicyclists, and people with disabilities). Additional benefits include minimizing adverse effects to the environment, and the improvement of aesthetic features in the surrounding area.

The project consists of the installation of a new P.C.C. Curb & Gutter and Sidewalk. The new Curb & Gutter and Sidewalk will connect to the existing A.C. Pavement and follow the existing elevations of the pavement surface. Stormwater will be directed north along the curb and diverted through sidewalk drains into a new swale/retention basin behind the sidewalk. New concrete handicap ramps will be added at intersections with Railroad Avenue (Alamo, Bonita, Church, and Date Street), with crosswalk striping at each crossing. Asphalt pavement will fill the gaps between the new curb and gutter and the existing pavement.







Railroad Ave. Pedestrian Improvements from Main Street/SR 115 to Date Street Calipatria, CA. VICINITY MAP MAP





A 2021 report titled "Community of Calipatria Summary and Recommendations Report," prepared by California Walks and the University of Berkeley Safe Transportation & Education Center (SafeTREC), found that vehicles appear to drive above the speed limit of 25 miles per hour at the northern intersection of the project site with Main Street/State Route 115 (refer to page 11 of the report). This further exacerbates the danger for pedestrians on the project site and illustrates the urgency for the city to develop the proposed project.

The proposed project consists of constructing an approximately 1,580-foot-long and 6-foot-wide sidewalk on the east side of Railroad Avenue between Main Street/SR 115 and Date Street. Railroad Avenue is primarily utilized by residents to access the adjacent residential area. The site has no pedestrian facilities, forcing residents to walk on the roadway or traverse the uneven native earth shoulder, which is blocked by overgrown vegetation throughout most of the segment. During rain events, the uneven shoulder pools stormwater, rendering the site untraversable. As an alternate route for Main Street, Railroad Avenue sees a significant vehicle count both northbound and southbound. The 2022 Caltrans Traffic Census Data estimated an Annual Average Daily Traffic (AADT) of 4000 vehicles along the intersection of Railroad Avenue and Main Street. The Proven Safety Countermeasures prepared by the U.S. Department of Transportation estimates that sidewalks provide a 65-89% reduction of crashes involving pedestrians. The project will reduce and prevent potential crashes involving pedestrians while also accommodating the current and future needs of nonmotorized travelers in the area. While the benefits are immense, the City of Calipatria must rely on funding from CMAQ since the city's small population renders it unable to acquire funds for this and other vital infrastructure projects outside of grants.

The planning, PA&ED, and PS&E phases of the project consist of preconstruction items (e.g., designs, obtaining permits, locating monuments, advertisements, etc.) and are expected to be completed by September 2027. Right-of-Way is not required, as the site is under the City of Calipatria's jurisdiction. The construction phase is set for November 2027 to July 2028 and will consist of the installation of a new P.C.C. curb & gutter and sidewalk. Sidewalk drains will reduce flooding, and the sidewalk will connect to and follow the current elevations of the existing pavement surface.

In a 2021 report titled "Community of Calipatria Summary and Recommendations Report" prepared by California Walks and the University of Berkeley Safe Transportation & Education Center (SafeTREC), Railroad Avenue was noted to have vehicles appear to drive above the speed limit of 25 miles per hour at the northern intersection of the project site with Main Street/State Route 115 (Page 11, https://www.google.com/url?sa=t&rct=j&g=&esrc=s&source=web&cd=&ved=2ahUKEwiij9rroLWOAxVql UQIHRJAHbwQFnoECBQQAQ&url=https%3A%2F%2Fsafetrec.berkeley.edu%2Fsites%2Fdefault%2Ffiles%2 F2021 cpbst calipatria report.pdf&usq=AOvVaw2-PlbNZ7QIyw9Up6cUcyrm&opi=89978449). This poses a significant safety risk for pedestrians and other nonmotorized modes of transportation. Railroad Avenue is also identified as the 5th most recommended development for the City of Calipatria on the 2022 Active Transportation Plan (ATP) prepared by the Imperial County Transportation Commission (ICTC). Under the ICTC ATP, the recommended development consists of a Class I multi-use path along Railroad Avenue (Pages 36-37 and 128-130, Transportation Plans & Studies | Imperial County Transportation Commission). This is similar to the City of Calipatria Circulation Element of the 2013 General Plan, which lists the development of Class II bicycle facilities on Railroad Avenue between Bonita Street and Main Street/State Route 115 (Pages IV-12 - IV-14). The pedestrian improvements to Railroad Avenue are intended to comply with the recommendations of all three referenced plans and become the first step towards the eventual completion of a complete pedestrian and non-motorized transportation network throughout the city.

According to the Grant Location Verification map prepared by the U.S. Department of Transportation, both the project site and the City of Calipatria are located within Census Tract 101.02, which is designated as an area of persistent poverty. The City of Calipatria is predominantly a low-income community, as approximately 30%-40% of the population lives below the poverty level. The project area is considered to be a disadvantaged and historically underserved community, as it is regarded as a community of concern, a disadvantaged community, and an AB 1550 community by the SCAG REAP 2.0 Indicator Mapping Tool (refer to Figures 1-3 attached). The city has historically lacked the necessary funds to fund pedestrian

improvement projects, resulting in a severe lack of pedestrian and nonmotorized facilities in the city, as illustrated on Page IV-18 of the 2013 City of Calipatria General Plan. The project site is currently located adjacent to a residential zone and is utilized by residents to travel towards Main Street/State Route 115. From there residents typically travel west towards the main commercial hub of the city or northeast towards the nearest city park. A 2021 report titled "Community of Calipatria Summary and Recommendations Report," prepared by California Walks and the University of Berkeley Safe Transportation & Education Center (SafeTREC), found that drivers typically drive above the 25 miles per hour speed limit at the intersection of Railroad Avenue and Main Street/State Route 115 (refer to page 11 of the report). The proposed project will not only fill a critical infrastructure gap along Railroad Avenue but also provide a reliable and safe pedestrian facility for the historically disadvantaged community. The proposed project will also pave the way for the development of a future bicycle network along Railroad Avenue as recommended by the 2013 City of Calipatria General Plan and the 2022 Imperial County Transportation Commission (ICTC) Active Transportation Plan (ATP).

INTRODUCTION AND BACKGROUND

On March 31, 2025, the Southern California Association of Governments (SCAG) initiated a call for project nominations for the Surface Transportation Block Grant (STBG) for federal fiscal years 2026-2027 and 2027-2028. The STBG Program is a federal transportation funding source for projects that preserve and improve the conditions and performance of highways, bridges, and public roads; pedestrian and bicycle infrastructure; and transit capital projects. In response to the call for project nominations, the City of Calipatria applied for STBG funding for the West Main Street Roadway Improvements between International Boulevard and Lyerly

Road. To proceed with the application, applicants are required to submit a resolution, from their governing bodies, authorizing the application submittal. Draft resolutions are permitted on the condition that an executed resolution be provided soon upon submittal.

The purpose of this item is to present the STBG application for the West Main Street Roadway Improvements Project to the City Council where they will review all pertinent information and motion to either adopt or not adopt a resolution authorizing the submittal of an STBG application for federal funding.

ISSUES FOR DISCUSSION

The proposed project is an approximate 2,640 foot long and 72-foot-wide segment of West Main Street between International Boulevard and Lyerly Road. West Main Street is designated as a major collector by the City of Calipatria General Plan which according to the 2022 Department of Transportation Traffic Census Data has an estimated Annual Average Daily Traffic (AADT) of 4,000 vehicles traveling south and west and an estimated AADT of 4,000 vehicles traveling north and east. It is the primary street conduit for agricultural, geothermal and other commercial and industrial traffic as well as for residential traffic within the City of Calipatria. The proposed project site borders the Calipatria Unified School District and is the primary access roadway for the Elementary, Junior High and High School facilities.

The subject street segment is exhibiting severe "alligator cracking" and long cracks along sections of the roadway due to high volumes of traffic. The remaining pavement surface is unsalvageable and is in poor condition. The City has been maintaining the pavement surface of this section periodically; however, this roadway section is overdue for rehabilitation as the maintenance treatment can no longer repair the roadway section due to the alligator cracks and pavement failures evident on the roadway surface. This proposed project will consist of cold planing the top 2 ½ inches of the existing asphalt. Damaged pavement areas will be repaired with new conventional asphalt to match the cold planed surface. A 1-inch leveling layer of asphalt will be applied, followed by a Class I pavement grid to reduce reflective cracking. A 1 ½ inch layer of Asphalt Rubber Hot Mix (ARHM) will be placed on top. Pavement striping will occur after the AHRM is applied. Water Pollution Control Program (WPCP) measures will be implemented to manage construction and stormwater runoff.





Project Description*	The proposed project consists of the rehabilitation of an approximately 2,649-foot-long and 72-foot-wide segment of West Main Street between International Boulevard and Lyerly Road. The project site allows for two (2) traffic lanes on both sides along with parking along the street edges. The site also borders the Calipatria Unified School District and serves as the primary access route to their K-12 facilities. The city has routinely serviced and maintained the road segment, but the severe "alligator cracking" and heavy traffic volumes have rendered the full rehabilitation of the road segment necessary. The subject road segment is a part of a larger project intended to rehabilitate West Main Street from Sorenson Avenue to Lyerly Road. Segments of Main Street east of International Boulevard received prior STBG funding, and this proposal will rehabilitate the remaining segment of Main Street from International Boulevard to Lyerly Road.
	The rehabilitation and resurfacing of the existing roadway will be conducted in accordance with Caltrans Local Assistance Procedures Manual (LAPM) standards and applicable city regulations. The existing asphalt concrete (A.C.) pavement will be cold planed to a depth of 2-1/2 inches, followed by the removal and replacement of deteriorated pavement sections. A rubberized crack sealant will be applied to existing pavement cracks, followed by the installation of a 1-inch A.C. leveling course and Class I pavement grid. A 1 to 1/2-inch asphalt rubber hot mix (ARHM) overlay will be placed over the prepared surface. The project also includes the construction of new ADA-compliant P.C.C. handicap ramps, along with pavement markings and striping per Caltrans Standard Plans. Signage and directional arrows, crosswalks, lane lines, centerlines, and channelizing striping are also planned. Traffic control measures will be conducted throughout the construction period to ensure public safety and minimize disruptions.

Project Description/Scope and Location

SCOPE AND LOCATION

The proposed project will rehabilitate an approximately 2,649-foot-long and 72-foot-wide segment of West Main Street between International Boulevard and Lyerly Road. West Main Street is classified as a major collector by the City of Calipatria's 2013 General Plan (Pages IV-3 - IV-5), 2018 Service Area Plan (Pages 4-29 - 4-30), and the California Department of Transportation's (Caltrans) Functional Classification System. The project site directly adjoins and serves as the primary route to the only elementary, middle, and high schools in Calipatria. The California Department of Education's California Dashboard Navigator estimates that all three schools had a total of 1,022 students enrolled in 2024, which is approximately 15.67% of the estimated July 1, 2024, Calipatria population identified by the U.S. Census Bureau. This makes West Main Street one of the most trafficked segments in the city. The segment also receives a significant amount of commercial and industrial traffic as it serves as a conduit for agricultural, geothermal, and freight travel. Most of this traffic comes from the intersection of Sorenson Avenue/State Route 111 and Main Street/State Route 115, which Caltrans estimates to have an Annual Average Daily Traffic (AADT) count of 5,700 vehicles traveling south and west, and 5,400 vehicles traveling north and east, according to their 2023 Traffic Census Program. The large traffic count greatly diminishes the durability of the road segment, requiring constant and periodical maintenance from the city, which is no longer feasible due to the segment's extensive "alligator cracking." The improvements to West Main Street will not only improve travel but also greatly increase safety in the area. While the benefits are immense, the city relies on STBG funding since the small population renders it unable to acquire funds for this and other vital infrastructure projects outside of grants. The CON phase will begin in November of 2027 and end in July of 2028.

The city is well-equipped to manage cost increases that exceed the grant program's funding by leveraging internal financial resources and careful budget planning. It has set aside specific funds for capital improvements and transportation infrastructure, which while limited, can be used to cover unexpected costs, such as rising material prices, labor shortages, or unforeseen site issues. Additionally, the project budget includes a 10% contingency to manage cost overruns without affecting the scope or project timeline. If further funding is necessary, the city can redirect funds from lower-priority projects or tap into its limited reserve funds. This layered strategy allows the city to keep the project on track and on schedule, even if expenses go beyond the grant's coverage.

The proposed road segment is classified as a major collector and is the primary route to the Calipatria Unified School District's K-12 facilities. Apart from education facilities, the school district also opens its pool and fields to the general public during the summer. As the only such facilities in the city, residents across the entire city and surrounding communities often travel to the area to access these locations. Furthermore, West Main Street is part of a fixed route for public transit as illustrated in the Imperial County Transportation Commission's (ICTC) 2024 Regional Long-Range Transportation Plan (Pages 60-65), ICTC's 2019 Short Range Transit Plan (Pages 25-26 and 44-45), and the City of Calipatria 2013 General Plan (Pages IV-9 – IV-

11). This route is vital for connecting the city to nearby southern communities. The City of Calipatria is predominantly a low-income community, as approximately 30%-40% of the population lives below the poverty level. The project area is considered to be a disadvantaged and historically underserved community, as it is regarded as a community of concern, a disadvantaged community, and an AB 1550 community by the SCAG REAP 2.0 Indicator Mapping Tool (refer to Figures 1-3 attached). While Calipatria is designated as a disadvantaged community suffering from persistent poverty by the U.S. Department of Transportation Grant Location Verification map, the city is also identified as a community with one of the highest transit dependencies according to the ICTC Regional Long Range Transportation Plan (Pages 63-64). These plans further cement the project's importance to improving the Calipatria community's access to everyday destinations.

NOW THEREFORE, BE IT RESOLVED, that the City Council of the City of Calipatria hereby agrees to ensure that all project delivery deadlines for all project phases will be met or exceeded, and:

- A) The opportunity for public comment was provided at a public meeting; and
- B) Local funds in the amount of \$188,000 (11.51%) from the City of Calipatria streets fund (Local Transportation Authority (LTA) Measure D) will be used to leverage the federal funds for the project; and
- C) Project is consistent with the Circulation Element of the City of Calipatria; and
- D) Project is consistent with the adopted pavement management plan; and
- E) The Calipatria City Council hereby designates and authorizes the City Manager or his/her designee to sign, execute and submit all documents including, but not limited to:

Applications, fund transfer agreements, payment requests, and amendments which may become necessary for the completion of the grant application and approval process for the program.

BE IT FURTHER RESOLVED, that failure to meet project delivery deadlines may be deemed as sufficient cause for the Imperial County Transportation Commission Policy Board to terminate an agency's project and reprogram Federal/State funds as deemed necessary; and

That the City of Calipatria City Council does direct its management and engineering staff to ensure all federal and state-funded projects are carried out in a timely manner as per the requirements of AB 1012 and the directive of the City of Calipatria City Council.

Project: Authorization to Advertise Invitation for Bids - Main Street Roadway

Improvements from Lake Avenue to International Boulevard

SUMMARY

The City of Calipatria received funding through the Surface Transportation Block Grant (STBG) for street improvements along Main Street between Lake Avenue and International Boulevard. The City received \$298,000 for Construction (CON) FY during 2024/2025 with a local match of \$39,000 to be covered with the Local Partnership Program (LPP) funds totaling \$337,000 in available funds.

PROJECT SCOPE

The proposed project scope includes rehabilitation of the street section on Main Street between Lake Avenue and International Boulevard. The project consists of saw cutting the failed A.C. pavement areas after the cold planing of 2½ inches of A.C. asphalt pavement. The conventional A.C. pavement will be placed within the pavement failure areas from the underlying class 2 base to the level of the cold planed surface. A 1-inch leveling course of conventional A.C. pavement will be placed over the cold planed and pavement failure areas. A Class I pavement grid will be placed over the 1-inch leveling course to inhibit reflective cracking. A 1½ inch Asphalt Rubber Hot Mix (ARHM) will be placed over the Class I pavement grid and leveling course. Pavement striping is to occur after the placement of the ARHM pavement.

Professional services of qualified Construction Management consultants must also be procured to perform resident engineering activities to ensure adherence to improvements plans, specifications, construction details, and construction contract documents. The City

Council's action includes authorization to advertise Request for Proposal (RFP) for Construction Management.

The project timeline for the City of Calipatria Main Street Roadway Improvements between Lake Avenue to International Boulevard is as follows:

The advertisement for bids will be published in the Desert Review on August 20 and August 27. Following that, a bid opening will be conducted at City Hall on September 5. The City Council will meet on October 14 to approve the award of the construction contract to the lowest responsive and responsible bidder. Once approved, a Notice to Proceed will be issued on October 31, officially authorizing the contractor to begin work. Construction activities are scheduled to begin on November 10 through March 9, which is during the 120 calendar day construction window. Finally, the project is anticipated to file the Notice of Completion on March 9. Please refer to Attachment A – Schedule of events for a more detailed breakdown.

FISCAL IMPACT

An Engineer's Opinion of Probable Cost (Attachment B) for the proposed project scope and estimated a total project cost of \$337,000.00 as shown in the table below.

The Holt Group prepared an Engineer's Opinion of Probable Cost which includes but is not limited to removing and disposing of the full depth of the existing A.C. pavement, installing 3 ½" of A.C. pavement, installing 1" of conventional A.C. leveling course, demolish and dispose of the existing P.C.C. collars, and striping and signage. The estimate also includes geotechnical testing. Refer to Attachment B for more details.

The City of Calipatria received funding through the Congestion Mitigation and Air Quality (CMAQ) for street improvements along South Brown Avenue between Main Street/SR 115 to Church Street. The City received \$1,649,000 for Construction (CON) during FY 2024/2025 with a local match of \$214,000 to be covered with the Local Partnership Program (LPP) funds totaling \$1,863,000 in available funds.

PROJECT SCOPE

The proposed project scope includes rehabilitating and expanding the existing segment of South Brown Avenue between Main Street/SR 115 and Church Street. The project proposes to rehabilitate and widen the pavement of Brown Avenue from SR 115 to Church Street, including curb and gutter, to designed capacity. The project would involve saw cutting and removing dilapidated segments and replacing them with 3 inches of A.C. (asphalt) Pavement over 9 inches of class 2 base. The pavement will be widened to 45 feet as measured from face-of-curb to face-of-curb and also with 3 inches of A.C. Pavement over 9 inches of 2 class base. The pavement width will accommodate two travel lanes and on-street parking. No new travel lanes will be added.
